Document No. 25—Report of the COMMITTEE ON FINANCE AND TAXATION, as follows:

To the Officers and Members of the Grand Court:

Your Committee on Finance and Taxation begs leave to report as follows:

We have examined all bills incurred at this session and we recommend that they be paid.

We have examined the accounts of the various Grand Court Officers as printed in the Advance Reports. We find them correct as to the summary of financial operations they cover and recommend that they be approved.

Your Committee has carefully examined the budget items as printed in the Advance Reports. Believing it will be the policy of this Grand Court Session to continue the operations of the Grand Court as in the past and taking into consideration the number of members on which tax will be paid throughout the year your Committee recommends a per capita tax of \$1.70 per member per annum. Of this amount \$1.60 is for general expenditures and ten cents is for organization work. We further recommend that the tax be paid as follows:
